ELIGIBILITY: Entry is open to any team comprised of a parent and child in any age combination **excluding male-male**. Step-parents and grandparents are allowed. In-laws are NOT eligible. A contestant may play with more than one family member at the same time or may play in both the morning and afternoon session to accommodate multiple team entries. At least one member of the Parent/Child team must be a current resident of Iowa.

DIVISIONS: There are three separate divisions. The Open Division, the Young Adult Division (the child is 11 or 12 years old), and the Junior Division (the child is 10 years of age or younger). The Junior Division is broken into two flights; the 8 & under flight and the 9 & 10 year olds. Be sure to mark the correct division or flight you wish to enter on the application form (reverse side). **NOTE:** It is the Parent's responsibility to ensure that a child has both the ability and focus to participate in a competitive event.

FORMAT: All teams will play 18 holes of alternate shot. Before play begins, each team will designate one member to tee off all the odd holes, the other team member will tee off all the even numbered holes. Open Division teams must choose one of two sessions to play in – Saturday AM or Saturday PM. The Young Adult Division teams (11-12 years of age) will tee off last in the Saturday PM session. Tee times begin at 8 AM in the morning session and at 1 PM in the afternoon session. Junior Division teams will play 18 holes on the Par-3 Course with tee-times beginning at 9:00 AM. The child cannot have reached his 11th birthday on or before June 30th, 2007 to compete in the Junior Division. Each session will be flighted by 18-hole score with the number of flights depending on the number of entries.

PAIRINGS, TEE-TIMES: Play will be conducted from both #1 and #10 tees from 8:00 AM to 9:30 AM or 1:00 PM to 2:30 PM on Saturday. You must request AM or PM on your entry application. Junior Division will tee-off from 9:00 AM to 10:00 AM on Saturday on the Par-3 Course. The Young Adult Division will tee off from 1:30 to 2:30 on Saturday on the regular course. The IGA will make all attempts to meet pairing requests. **We cannot guarantee that every request will be met.**

PRACTICE PRIVILEGES: Practice rounds are at the discretion of the host course in terms of starting times and fees. Players are responsible for scheduling their own tee times with host club.

WITHDRAWALS AND REFUNDS: Entry fees will be refunded if the IGA office is notified on or before Friday, June 21, 2007. After June 21 fees will be refunded only in event of injury or illness. There will be a \$20.00 service charge on all refunds.

ENTRIES — FORM, FEE, CLOSING DATE:

Entrants are solely responsible for securing and returning entry forms and fees by the due date. Entries must reach the IGA office by 11:59 P.M. on Thursday, June 21 and must be accompanied by the appropriate fee. You may enter online using a credit card at www.iowagolf.org up to the deadline or until a field limit is met. Late, unsigned or incomplete applications are not acceptable and will be returned. **Late entries may be accepted at the discretion of the committee and only to fill openings in the existing pairings!**

CONDITIONS, SCHEDULES: The committee reserves the right to alter any of the conditions and schedules herein as needed. This may include, but is not limited to, suspending play to a following day, or cancelling current or future rounds. The decision of the Championship Committee in any matter shall be final. Under any circumstances, all possible attempts will be made to complete the event in the scheduled number of rounds.

PERSONAL APPEARANCE: Proper golf attire is mandatory; the committee reserves the right to determine whether this requirement is met. Competitors may be required to change clothing to compete. Shorts are permitted, provided they are Bermuda length or longer. **T-shirts, tank tops, gym shorts, sweatpants and blue jeans are NOT permitted.**

PACE OF PLAY: In accordance with Note 2 under Rule 6-7, the IGA has adopted pace of play guidelines that include the maximum period of time allotted to complete a stipulated round, a hole, or a stroke. These guidelines and the resulting penalties will be made available to every competitor.

RULES OF GOLF: Play will be governed by the 2006-07 USGA Rules of Golf. Local rules on scorecards do not apply. Decisions concerning the rules will be settled by the Rules Committee assigned by the IGA and those decisions will be final.

FORM OF PLAY: 18 holes of modified alternate shot where the team must decide at the start of the round which player will tee off on the odd numbered holes, the other player will tee off on the even numbered holes
