Eligibility: Participants must legally be husband and wife, maintain a residence in the state of Iowa and have a 2010 club or individual membership with the IWGA.

Field: The field will be limited to the first **180** entrants. Entries will be accepted on a first come first serve basis.

Format: The tournament will be a 36 hole Modified Alternate Stroke event. Each partner will tee off, then choose the best ball and continue through the hole. Following the first round of play, teams will be flighted according to score. Regular Division players will have the option of either playing Thursday and Saturday or Friday and Sunday.

Super Senior Flight for those couples who have a combined age of 135 and desire to play a shorter course. The Super Senior Flight will **only** be played on Thursday and Saturday.

Rules of Golf: The 2010 Rules of Golf will govern play. Any exceptions will be determined and specified by the Championship Rules Committee.

Practice Rounds: Practice rounds for this event are available by contacting the Burlington Golf Club at (319) 752-3720. Price for this round will be \$50 per couple plus cart.

Dress Code: Players will be neat in appearance with respect to normal personal grooming and clothing at any IWGA sponsored championship. Appropriate golf attire is required (e.g. no short shorts, blue jeans or blue jean shorts, midriff tops, tank tops, halter tops, sports bras, gym shorts, leotards, undershirts or low rise shorts or slacks). Shirts with collars are required for men and soft spikes are required for all.

Entry Form, Fee, Closing Date: Entries must be postmarked by August 19. Entries must also be accompanied by the registration fee (\$160). Late, unsigned or otherwise incorrect entry forms will not be accepted and will be returned. Acceptance letters will be e-mailed after the entry deadline.

Withdrawals and Refunds: Entry fees will not be refunded after August 19, 2010. There will be a \$20 service charge on all refunds.
