

## HISTORY OF THE IWGA WIFE-HUSBAND TOURNAMENT

Compiled by Sally Sharp April of 1999.

Updated October 2001.

The tournament has always been held at Okoboji, Iowa at Brooks Country Club. However Brooks was at one time called Elm Brooks Country Club.

I.W.G.A. membership dues were required to play. They were \$10.00 through 1977. In 1978 they changed to \$15.00 until 1985. In 1985 they changed to \$20.00 until 1992. In 1992 they changed to \$25.00 until 1995. In 1995 they changed to \$35.00 and that is what they are as of 1999.

You or your club always had to be member of the I.W.G.A. in order to play. In 1982 you also were required to be a voting resident of the State of Iowa.

The tournament began as a two-day event and excelled to a four-day event in 1969. The tournament grew to the point that in 1998 the four-day event was limited to 264 couples as it is today. Some couples play Thursday and Saturday and others play Friday and Sunday.

The tournament was called the I.W.G.A. Husband and Wife until 1964 when it was changed to the Wife-Husband Tournament. The name of the tournament went back and forth like this until 1977 when it became consistently the I.W.G.A. Wife-Husband Tournament. In 1983 we added the year to the name of the tournament. Example: 24<sup>th</sup> Annual I.W.G.A. Wife-Husband Tournament.

Entry fees were \$20.00 per couple in 1961 until 1975. In 1975 they changed to \$25.00 until 1977. In 1977 they changed to \$35.00 per couple until 1988 when they changed to \$42.00 which included tax. In 1994 they changed to \$45.00 tax included. In 1995 it became mandatory that all players must ride and all carts would be rented from Brooks. The cart fee was \$24.00 per day or \$48.00 for the tournament and had to be paid with the entry fee. In 1996 the entry fee was \$50.00 per couple and \$48.00 for a cart for two days. The entry fee in 1998 became \$110.00 per couple, which included cart and tax. The tournament entry fee for 1999 remains the same as 1998.

In 1998 soft spikes became mandatory.

In 1968 the I.W.G.A. began printing zip codes with mailing addresses.

1982 was the first year that the complete entry blank was printed in the I.W.G.A. book.

In 1973 we charged \$3.00 per couple for a Friday and Saturday night buffet.

The year 1988 was the first year that prizes were listed in the book. They were gift certificates to the pro shop of \$70 - \$60 - \$40 - \$30 per flight. In 1995 the \$30.00 prize was dropped.

In 2002 the IWGA held a special meeting regarding the location of the Wife-Husband tournament. They offered any IWGA member club to make their presentation as to what they could do for the IWGA and the Wife-Husband tournament. Burlington Golf and Country Club, Burlington was awarded the Wife-Husband Tournament for 2003.
